AMENDMENT TO MASTER MANAGED SERVICES AGREEMENT

This AMENDMENT No. 2 ("Amendment") is effective as of January 25, 2024 ("Effective Date") and supplements/modifies the Master Managed Services Agreement dated January 30, 2019 ("Agreement") between Canon Solutions America, Inc. ("CSA") and Virginia Commonwealth University ("Customer") as follows:

- 1. All defined terms shall have the meanings set forth in the Agreement unless expressly defined herein.
- Notwithstanding Section 2.2 of the Agreement, CSA and Customer hereby mutually agree to extend the initial Term of the Agreement for a period of two (2) years. As so extended, the Agreement shall have a revised expiration date of January 29, 2026.
- 3. The parties acknowledge and agree that CSA has paid to Customer the first two (2) \$100.000.00 installments of the Transition Payment provided for in Section 1.4 (Transition Services) of the Agreement based on the fact that Customer has placed more than two hundred (200), but less than three hundred (300), units of Equipment under the Agreement as of the Effective Date of this Amendment. Notwithstanding the language in Section 1.4, CSA shall pay the third \$100,000.00 installment of the Transition Payment provided Customer accepts delivery of the three hundredth unit of Equipment on or prior to June 30, 2024. Effective January 30, 2024 the parties acknowledge and agree that the provision of the additional seventy-five thousand dollar (\$75,000.00) Transition Payment related to the installation and acceptance of the 351st unit of Equipment shall be discontinued.
- 4. As of the Effective Date, Attachment 1 to the Deliverables Supply Addendum to the Agreement is hereby deleted in its entirety and replaced with Attachment 1 with a revision date of January 30, 2024, attached hereto.
- 5. CSA will reduce the monthly base charge associated with the in-place Output Devices being retained by Customer by twenty percent (20%) effective upon the expiration of their initial Usage Term and the Usage Term therefore shall continue until January 29, 2026 in connection with the ongoing provision of Services under the Agreement. A list of in-place Output Devices, along with their current monthly base charge and initial Usage Term expiration date, is attached hereto as Exhibit 1.
 - a. The revised monthly base charges listed in Exhibit 1 are contingent upon Customer retaining the Output Devices throughout the entirety of the revised Term of the Agreement as noted in Section 2 herein. Should Customer cancel any Output Devices prior to the expiration of its extended Usage Term, Customer shall pay to CSA, in addition to any outstanding charges, if any, an early termination fee in an amount equal to the monthly base charge for such terminated Output Devices times the remaining payments.
 - b. For the avoidance of doubt, Customer will continue to pay the existing per impression charges associated with each Output Device.
 - Notwithstanding the above, Customer shall not be charged an early termination fee should the Output Devices be replaced by new Output Devices from CSA.
- Both parties agree that an electronic image of this Amendment may be accepted as an original, and that electronic copies of all signatures will be treated as originals for all purposes.
- 7. Except as supplemented/modified hereby, all terms of the Agreement remain in full force and effect and are ratified and confirmed in all respects.

IN WITNESS WHEREOF, each of the undersigned have caused this AMENDMENT to be executed by their duly authorized officials effective as of the Effective Date, intending to be legally bound hereby.
