

**ASSIGNMENT AGREEMENT
FROM
AMERGENT, INC.
TO
MOORE, A SERIES LLC**

This assignment is made and entered into on January 1, 2024, between Amergent, Inc. (“Assignor”), Virginia Commonwealth University (“Client”), and Moore, a Series LLC (“Assignee”).

WHEREAS, Assignor and Client are parties to a direct mail services agreement, Contract No. C0003112, dated July 1, 2023, as follows: Master Services Agreement (the “Agreement”) pursuant to which Assignor and Client agreed to the provision of direct mail services and related services provided by Assignor to Client as outlined in said Agreement; and

WHEREAS, Assignor and Assignee are affiliated companies; and

WHEREAS, Assignor desires to assign the Agreement to Assignee, and Assignee desires to accept such assignment, in order to consolidate, improve, and enhance the constituent marketing experience for its enterprise customers such as Client; and

WHEREAS, Assignee is a state-registered professional fundraising consultant fully capable of performing the duties of Assignee as contained in the Agreement; and

WHEREAS, pursuant to Section 6.G. of Contract No. C003112, any such assignment, in whole or part, requires, the written consent of Client; and

WHEREAS, Client wishes to continue with the direct mail services and does consent to the proposed assignment.

NOW THEREFORE, in consideration of the assignment and of the promises and covenants contained herein, the sufficiency of which is acknowledged by the signatures of the parties hereto, it is hereby agreed as follows:

1. **Assignment.** Assignor hereby assigns to Assignee all of Assignor’s right, title, and interest in and to the Agreement, and Client consents to said assignment. Assignee hereby assumes all of the duties and obligations of Assignor to perform the services set forth in the Agreement from the date of assignment through the remaining term of the Agreement.
2. **No Other Changes/Modifications to the Agreement.** Except for the assignment of the Agreement as stated herein, no other changes to the Agreement are made and the Agreement remains in full force and effect in accordance with its terms as of the date hereof.
3. **Effective Date.** This assignment is effective as of the date stated above and will continue through the remaining term set forth in the Agreement being assigned hereunder.
